● TAKE RESPONSIBILITY:

- IF YOU DON'T KNOW YOUR RIGHTS, YOU HAVE NO RIGHTS.
- TIME IS OF THE ESSENCE.

● TAKE ACTION:

- OPEN YOUR BUSINESS, NO MASKS, NO SOCIAL DISTANCING.
- STUDY THE CONSTITUTION AND SHERIFF HANDBOOK.
- SHARE WITH OTHERS AND SHARE THE CLG WEBSITE.

● SHERIFF'S AUTHORITY AND OATH:

- UNITE WE THE PEOPLE WITH THE SHERIFF.
- PRINT OFF AND READ THE SHERIFF'S HANDBOOK AND SCHEDULE A MEETING WITH SHERIFF.
- IF THE SHERIFF IS UNCONSTITUTIONAL AND NOT UPHOLDING HIS OATH OF OFFICE CREATE A PETITION TO RECALL

HIM/HER. GET SIGNATURES AT RALLY'S. DRAFT A PRESUMPTIVE LETTER WITH A 10 BUSINESS DAY WAIT, THEN AN AFFIDAVIT OF TRUTH AND FACT.

- **RIGHTS VIOLATED DUE TO FORCED UNLAWFUL MASK WEARING & SOCIAL DISTANCING:**

- PRINT OUT OUR NOTICE OF DISCRIMINATION AND CARRY WITH YOU AT ALL TIMES.

- DOCUMENT NAMES, DATE, PLACE AND GET BUSINESS CARDS OF THE OWNER OR MANAGER, ETC. VIDEO TAPE THE ENCOUNTER AND TAKE PHOTOS. FILE A DISCRIMINATION CHARGE (CIVIL RIGHTS ACT OF 1964) WITH THE SHERIFF'S OFFICE.
- FILE AN AFFIDAVIT OF TRUTH & FACT AGAINST ALL PARTIES WHO CAUSED YOU INJURY. THEY MUST BY LAW PROVIDE REMEDY FOR THEIR TRESPASS ON YOUR RIGHTS. INSTRUCTIONS ARE ON THE CLG WEBSITE.
- MASKS CAUSE HYPERCAPNIA, HYPOXIA, SKIN INFECTIONS AND DENTAL PROBLEMS.
- FILE AN SF95 WITH THE DEPT. OF HEALTH & HUMAN SERVICES

- **REMEDY:**

- STRENGTH IN NUMBERS.
- WEBSITE, RESOURCES, TAKE ACTION.
- FILE AFFIDAVIT OF TRUTH & FACT AGAINST THE GOVERNOR, HEALTH DISTRICT WORKERS, LIQUOR BOARD EMPLOYEES, ETC. IN THEIR PRIVATE CAPACITY. **THEY ARE OUR SERVANTS!**

- 10 BUSINESS DAYS TO REBUT.
- TRUTH, FACT, LAW AND EVIDENCE.
- ONCE UNREBUTTED, FILE A COMPLAINT AT THE SHERIFF'S OFFICE TO HAVE THE GOVERNOR ARRESTED AND ATTACH THE AFFIDAVIT OF FACT.

● **SCHOOLS**

- YOUR OFFSPRING ARE YOUR BIOLOGICAL PROPERTY. YOU CANNOT BE DEPRIVED OF YOUR PROPERTY WITHOUT DUE PROCESS OF LAW. **4th AMENDMENT**, THE RIGHT OF THE PEOPLE TO BE SECURE IN THEIR PERSONS SHALL NOT BE VIOLATED. **1st AMENDMENT, 9th AMENDMENT, 10th AMENDMENT, 14th AMENDMENT SEC. 2 & 3**
- IF YOUR OFFSPRINGS HEALTH IS AT RISK, GO TO THE SCHOOL AND GET THE NAMES OF THE SUPERINTENDENT, PRINCIPAL, VICE PRINCIPAL, TEACHER, NURSE, SCHOOL ADMINISTRATOR AND ALL INVOLVED IN VIOLATING AND ENDANGERING THE HEALTH AND SAFETY OF YOUR BIOLOGICAL PROPERTY WITHOUT AND AGAINST YOUR CONSENT.
- FILE A CRIMINAL COMPLAINT WITH THE COUNTY SHERIFFS OFFICE OF CHILD ENDANGERMENT. THEY MUST RESPOND TO THIS WITHIN 14 DAYS OF THE DEMAND WITH AN UNREBUTTED TESTIMONY OF AN AFFIDAVIT OF FACT AND TRUTH. THIS MUST BE BASED ON SOLID RESEARCH AND TESTIMONY OF RESPECTED PROFESSIONALS IN THE MEDICAL AND SCIENTIFIC FIELD.

● **VACCINES**

- PRINT OUT THE PERSONAL AFFIDAVIT AND WARRANTY OF VACCINE EFFICACY AND SAFETY ON OUR WEBSITE AND GIVE IT TO YOUR DOCTOR AND SCHOOL ADMINISTRATORS TO SIGN THIS CONTRACT TAKING **FULL RESPONSIBILITY** THAT IS SUBJECT TO NO IMMUNITIES FOR ANY AND ALL DAMAGES RELATED TO IMMUNIZATIONS AND FACE MASK WEARING.
- **ALL PUBLIC SERVANTS SHALL BE HELD ACCOUNTABLE TO THE FULLEST EXTENT OF THE LAW FOR THEIR VIOLATIONS OF THE PUBLIC TRUST.**
- **IGNORANCE OF THE LAW GIVES NO REMEDY TO THOSE IN VIOLATION OF THE LAW AND THEIR OATH OF OFFICE. THOSE WHO TOOK AN OATH OF OFFICE AND VIOLATE IT ARE SUBJECT TO THE PAINS AND PENALTIES TO THE FULLEST EXTENT THE LAW WILL ALLOW.**
