COMES NOW Bamm Bamm Rubble, over the age of consent, cognizant of the importance of the matters stated herein and competent to give testimony, solemnly makes oath that the following statements being true and correct to the best of his knowledge:

1. I, Bamm Bamm Rubble, am the biological son and essential (primary) caregiver of Barney Rubble.
2. I have resided with Barney Rubble since XXXXX and have shared jointly in all aspects of life including home maintenance, property management, managing of finances, and self-care.
3. Barney Rubble has previously expressed verbally on many occasions that should he fall ill, I am to be responsible for any and all of his medical decisions and treatments.
4. To the best of my knowledge, Barney Rubble does not have a Medical Advanced Directive, Medical Power of Attorney or any other document that authorizes any man or woman to make medical decisions should he become unable to do so for himself.
5. On XXXX, Barney Rubble became ill and was transferred to Flintstone General Hospital, Big Boulder.
6. Barney Rubble has since been sedated rendering him unable to make his own informed decisions.
7. I, Bamm Bamm Rubble, have designated Sally Rubble, daughter of Barney Rubble, and Samantha Stone, life partner of Barney Rubble, as essential caregivers of Barney Rubble.
8. All essential caregivers have previously discussed this plan as it shall relate to medical treatment of Barney Rubble, in accordance with his wishes and demands.
9. I, Bamm Bamm Rubble, am the living man best suited to advocate for Barney Rubble.
10. I, Bamm Bamm Rubble, will honor and respect the wishes and demands of Barney

Rubble to the best of my knowledge and ability.

11. As such, the care plan I, Bamm Bamm Rubble, require to be integrated into the current care plan of Barney Rubble is as follows:

- a. Immediate incorporation of the Frontline COVID Critical Care Alliance (FLCCC) MATH+ Hospital Treatment Protocol for COVID-19, and most specifically the use of Ivermectin as a core component.
- b. Immediate introduction of adequate enteral nutrition.
- c. Immediate review of all sedative, paralytic and pain-relieving medications, with a focus on reduction of redundant, contraindicated, or unnecessary doses/orders.
- d. All procedures, medications, and treatments to be performed on Barney Rubble outside of this protocol and not in response to an emergent situation, must be explained in full and consent obtained by at least one essential care giver.
- e. I do not consent to any Covid19 vaccine otherwise known as an experimental gene therapy injection, any vaccination or injection, exploratory drugs, immunization, into or upon the body of Barney Rubble.
- f. I require instant access to my father, Barney Rubble's, electronic medical record upon request.
- g. I require access to my father, Barney Rubble, by one essential caregiver during normal visiting hours, and by request with at least one hour's notice.

12. I hereby and herein reserve the right to amend and make amendments to this lawful document as necessary, in order that the wishes and demands of myself and my partner may be ascertained and proceedings justly determined.
